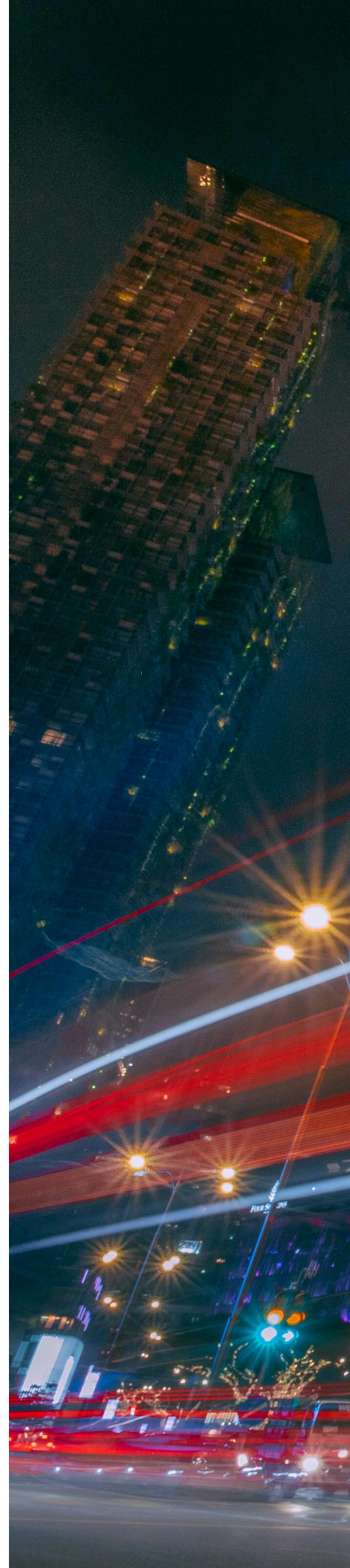
# About the Workshop

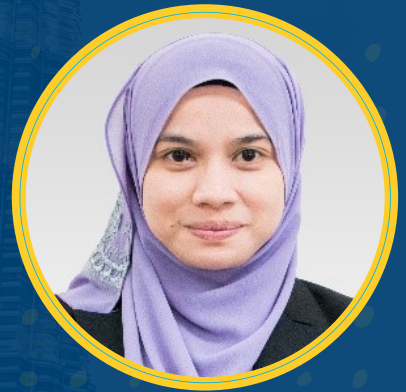
